French Government Scholarships

University students who are Czech citizens can apply for French government scholarships awarded by the French Embassy in the Czech Republic. The scholarships are intended for:

- **one- to three-month research internships**
- or
- **doctoral studies under joint supervision (doctorat en cotutelle)**

in the following fields:

- life and earth sciences
- engineering
- economics and law
- humanities and social sciences
- medicine
- linguistics and literature

Paul Robitschek Scholarship, University of Nebraska-Lincoln, USA

The Paul Robitschek Scholarship is awarded annually to Czech and Slovak university students. Successful applicants spend two semesters studying at the University of Nebraska-Lincoln (Nebraska, USA).

The scholarship covers tuition and university fees, accommodation and subsistence, textbooks and a return air ticket. Apart from proficiency in English, the eligibility requirements include willingness to maintain regular contact with the programme coordinator and to do part-time work on the university campus.

The candidate must also demonstrate sufficient academic aptitude and an interest in US political, economic and cultural life.

The application deadline for a given academic year is always 1 March of the previous year.

Scholarships for study periods at the National Institutes of Health/National Institute of Child Health and Human Development (Bethesda, USA)

This offer is intended for doctoral students at Charles University's medical faculties and the Faculty of Science. The candidates recommended by the faculty's doctoral studies subject-area boards submit their research projects in biomedicine or other fields to the Dean of the faculty, who will pass the projects on to the Vice-Rector for International Relations and Mobility, Professor Škrha.

If both Charles University and the partner institution endorse the project, the doctoral student will be awarded a NICHD scholarship, which covers one to two years of research work under the supervision of a NICHD tutor.

Candidates are required to have completed at least one year of doctoral studies. For the selection procedure they submit a CV (in English), a research project, a transcript of records for the entire course of their university studies, and two letters of recommendation.

The offer concerns the following research programmes: *gynaecology, bone and extracellular matrix branch, cell biology and metabolism, cellular regulation and metabolism, developmental and molecular immunity, developmental endocrinology and genetics, developmental neuroscience, genomics of differentiation, molecular medicine, perinatal research and obstetrics, physical biology, reproductive and adult endocrinology, nervous system development and plasticity, physical biochemistry*.

Applications can be submitted at any time during the academic year.

Baden-Württemberg-Stipendium is a scholarship programme promoting international exchanges for university and secondary school students, and also for graduates of vocational schools. Every year approximately 1,200 applicants receive scholarships for study periods abroad.

The Krsek Foundation offers a maximum of 10 scholarships enabling talented students to study at prestigious universities in the United Kingdom and the United States.

The scholarship is intended to cover one year's tuition fee for a Master's degree programme.

The intended beneficiaries are **students admitted** into a Master's degree programme in a **technical field, natural sciences, economics, history or political science** at any of the following universities: Harvard, Oxford, Cambridge, Caltech, Chicago, Columbia, MIT, Princeton, Stanford and UC Berkeley.

Applications can be submitted throughout the academic year.

CEEPUS is the Central European Exchange Programme for University Studies, which promotes cooperation within university networks.

The member countries are: Albania, Austria, Bosnia and Herzegovina, Bulgaria, the Czech Republic, Croatia, Hungary, Macedonia, Moldova, Montenegro, Poland, Romania, Serbia, Slovakia, Slovenia. Kosovo is a cooperating partner.

The programme targets undergraduate and postgraduate students and academics from public higher education institutions.

The scholarship can be applied either through the university network or outside it (if you want to go as a 'free mover').

Sciex Switzerland

SCIEX-NMSch (Scientific Exchange Programme between the New Member States of the EU and Switzerland) is a fellowships fund run as part of the Czech-Swiss Cooperation Programme.

The goal of SCIEX is to reduce social and economic inequalities in the enlarged European Union by strengthening research capacities and promoting research cooperation between Switzerland and the new EU member states (Bulgaria, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Slovakia, Slovenia).

The fellowships fund is targeted at doctoral students or postdoc researchers ('Junior Researchers') at Czech institutions that are eligible to apply for funding within the programme.

The Fulbright scholarships are not intended for students enrolled in Bachelor's programmes: applicants must be more advanced in their studies.

The International Visegrad Fund

The International Visegrad Fund (IVF) was established in 2000. Its member states (collectively known as the 'V4') are the Czech Republic, Hungary, Poland and Slovakia.

The objective of the fund is to foster closer cooperation among the member states and to strengthen mutual ties in the fields of culture, science and research, education, youth exchanges, tourism and cross-border cooperation.

Visegrad scholarships cover one to four semesters of a Master's degree programme or postgraduate study/research at any accredited public or private universities or accredited research centres of the Academy of Sciences in the V4 countries, but also in other countries.
