Types of Cards

All CU cards are equipped with a Mifare Classic contactless chip, a barcode, a signature strip, and a CU security holographic logo on the back of the card. The card displays the cardholder's identification details (first and last name, date of birth, personal ID number) and the card's validity. Cards with an ISIC/ITIC/ALIVE license show the ISIC/ITIC/ALIVE license number and the validity of the first year of the license (cards are now re-validated digitally, not by stickers anymore) Employee cards include information on the cardholder's affiliation to a CU department or faculty.

To access benefits and discounts, you can download your ISIC/ITIC/ALIVE card in digital form to your mobile device (**not valid for school purposes**). Requirements include a valid UK card with an ISIC/ITIC/ALIVE license, the Alive App (free to download from the [APP STORE](#) and [GOOGLE PLAY](#)), and an activated profile.

Users can view their digital card in the app, along with all discounts, competitions, and travel insurance details. The digital card version is valid for transportation and with discount providers. Students, teachers, and university staff can have their card and all its benefits readily available. For more information about the app, visit <https://www.aliveapp.cz>.

The reimbursement of overhead costs for the issuance or renewal of an ISIC or ALIVE student licence is **not applicable** if the student was granted a **social scholarship** at least once during the immediately preceding or current academic year, or if they hold a **TP, ZTP, or ZTP/P** disability card. Applications for the issuance or renewal of the licence can only be made in person at the card issuing centre.



Charles University Student Card with the ALIVE License






Charles University External Service User Card

- No fee for a replacement card is charged if the external service user presents a report from the Police of the Czech Republic proving the card was stolen



CU Alumni Club Membership Card




- Issued for a fee of 200 CZK

CU Alumni Club Membership Card with the ALIVE License




