Ph.D. Programmes

Doctoral Studies are one of the priorities of CU, with the objective of training students in independent research work and providing them with the appropriate qualifications in the given academic discipline. Successful graduates of doctoral studies, which usually take three to four years and culminate in a doctoral examination and the public defence of a doctoral (dissertation) thesis, obtain the academic title of Doctor (Ph.D.).

Entry into postgraduate programmes is based on the submission of a certificate of graduation from master's studies and an entrance examination. More specific entry requirements are determined in accordance with the law by the Dean of the relevant faculty.

Ph.D. Programmes

These programmes are open to those who have graduated from a university or other institute of higher education with a master's degree in Protestant Theology (or a related discipline) and thus provided evidence of their academic abilities. Applicants must also have passed examinations in at least one of the languages important for European theology, other than their mother tongue (i.e. German, English, French, Italian, or Spanish). Ph.D. programmes can be studied in either Czech, English, or German.

Postgraduate doctoral studies consist of research activity leading towards a written dissertation, the broadening and deepening of the student's knowledge in their chosen field of study, and the mastering of the techniques of academic work. Students are also required to attend certain lectures, seminars or convocations, pass an exam in a second language, write various papers, reviews, or literature searches, pass three exams in theological disciplines and have articles published in specialist journals. The student's individual study plan is worked out together with the student's supervisor. Students who meet these requirements and successfully submit and defend a dissertation are awarded the title of Ph.D. by Charles University.

Postgraduate doctoral studies (PDS) at the Protestant Theological Faculty are offered in the following fields:

- Biblical Studies
- Historical and Systematic Theology
- Practical and Ecumenical Theology and Theological Ethics
- Philosophy of Religion

The normal length of postgraduate doctoral studies is four years. The maximum duration of a study course is eight years.

Application procedure

Potential applicants should first contact the appropriate Head of Department (see the website) for the field in which they wish to write their dissertation, giving details of the topic for the dissertation and the language in which they will study. The Department will then consider if there is an appropriate person available to act as a supervisor. If so, and if possible in consultation with the prospective supervisor, the applicant should submit a written application that includes the following:

- application form
- curriculum vitae, including a detailed description of theological studies undertaken so far
- certified copy of Master's degree

- if possible, recommendation from a previous academic supervisor or teacher
- outline of the proposed dissertation project, including the topic, field, methods and aim of research (2–3 pages)

Entrance examinations then usually take place in June, consisting of an interview with members of the Faculty's Inter-Disciplinary Council for Postgraduate Studies, in which the applicant defends the outline of his or her proposed dissertation project.



The Hussite Theological Faculty offers the following Ph.D. programmes in English:

- Hussite Theology (four years)
- Jewish Studies (four years)

Hussite Theology – Characteristics:

The doctoral study programme “Theology”, the branch of study “Hussite theology” prepares students for independent scientific research and independent creative activities in the area of theology. The branch of study enables students to specialize according to his or her individual study plan. The branch of study provides knowledge of hermeneutical approaches and applies them in the contemporary theological discourse and also in the dialogue with confessional approaches of other theological systems. The subject of the studies is a theological compendium interpreted in the course of the Hussite theology. The goal of the studies is a scientific preparation of first-rate experts that are capable of independent scientific work in the area of theology. The branch is simultaneously oriented to awareness of the fact that from the very beginning there is an effort to new understanding and new interpretation of fundamental theological notions. Thereby the branch is in context with other concepts that were overcoming a metaphysical conception of the world. It deals with the key questions of the Christian belief and Christ presence in this world. Students of the branch have got an opportunity to learn how the questions are practically manifested in current social science of the church as well.

Jewish Studies – Characteristics:

The doctoral study programme “Theology”, the branch of study “Jewish studies” prepares students for independent scientific research and independent creative activities in the area of Jewish studies. The branch of study enables students to specialize in their profession according to his or her individual study plan. The branch of study develops intellectual legacy of Jewish studies and applies that in the contemporary religious situation of Judaism. The subject of the studies is Jewish history and culture, synagogue liturgy, Jewish religious philosophy, rabbi literature, reading and interpretation of selected texts of Babylonian Talmud and Hebrew language of rabbi texts. The goal of the studies is a scientific preparation of first-rate experts that are capable of independent scientific work in the area of Jewish studies. The branch is not nationally or confessionally defined but interprets Judaism as a religious phenomenon in the historical contexts overlapping into present problems. Learning about spiritual values of Judaism enables students to deepen their understanding of Christianity, primarily its ethics.

The Second Faculty of Medicine provides postgraduate doctoral studies in biomedicine together with the First Faculty of Medicine, the Third Faculty of Medicine, the Faculty of Science, the Faculty of Physical Education and Sports and Institutes of the Academy of Sciences of the Czech Republic oriented to biomedicine and departmental research institutes of the Ministry of Health of the Czech Republic. 3. Interest in work in selected subject of research and ability to perform scientific work.
4. Passing of entrance interview with at least 70 points.
5. Recognition of your university (master's) diploma.

In the framework of exams and particularly of defence of a dissertation thesis, a graduate must demonstrate competence for independent scholarly work.

The aim of the field of study is to deepen knowledge of the principles of European law acquired within the master's programme of study, including theoretical background of the field, as well as to gain more profound expertise regarding relations between European law and a variety of branches of domestic law. In the framework of exams and particularly of defence of a dissertation thesis, a graduate must demonstrate competence for independent scholarly work and follow-up application practice at an above-standard language competence in the main working languages of the European Union, be it English, French, or German.

Field specification

The aim of the field of study is to deepen knowledge of the theoretical principles of environmental law through studying both environmental issues and related theoretical public law issues as general background of the field. At the same time, study should help a doctoral student to get better oriented in a rather flexible field, which environmental law undoubtedly is (given the frequency of legislative amendments). What constitutes the basis of the field is understanding of systems of international law, European Community law, and Czech national law with the possibility of using theoretical and practical knowledge from the field of legal comparison. The acquired theoretical knowledge should serve as a basis for dealing with particular issues selected as the topic of the dissertation thesis. The dissertation should focus on theoretical legal issues and their possible application in follow-up practice.

Duration of study: generally 3 years

Requirements for successful completion of the programme:

Passing of 4 exams (2 foreign languages, general basics of jurisprudence, state doctoral exam related to the subject-matter of the chosen branch of the Ph.D. programme), writing of the doctoral thesis and its successful defence.

Organisation and requirements of the entrance examination:

A maximum amount of 60 points may be obtained in the entrance examination. The total number of points obtained by a candidate consists of aggregating scores in individual parts of the entrance examination. The points are distributed among individual parts of the entrance examination as follows:

- a professional discourse on the presented topic of the dissertation project (0–30 points);
- evaluation of previous professional activity (0–10 points);
- proving one's knowledge acquired by reading professional literature and knowledge of the respective field in the extent required for the State Final Examination, or, in the case of fields that are not subject to the State Final Examination, knowledge in the extent of an advancement examination (0–20 points).

An applicant who obtains at least 40 points in the entrance examination may be admitted to study. The maximum number of applicants admitted to the full-time study is determined by the decision of the Dean. The Dean will set the number before the regular date of the examination and a maximum number of admitted students will be posted in the public part of the website of the FoL.

Application particulars

The requisite documents which constitute a component part of an electronic application are as follows:

- an outline of the dissertation project in the extent of 5–7 text pages;
- a structured CV;
- a list of professional literature concerning the field of study; and
- an overview of past professional activities (e.g. works published, practical trainings and internships, etc.).

In the heading of the first page of each document attached to the application there must be the applicant's name, field of study and the name of the dissertation project. The applicant is obliged to choose from a list of supervisors for a given field a potential supervisor and indicate his/her choice in the application. The list of supervisors for individual fields of study is available at the website of the FoL CU.

Each document in PDF format must be attached to the application separately. Neither the application nor the attachments are to be printed out and sent by mail, with the exception of an authenticated copy of the higher education diploma and appendix to the diploma (or the Certificate of State Examination, in the case of previous graduates of CU); this obligation does not apply to students who have graduated from the Faculty of Law of Charles University since 1 January 2008 (the Faculty will verify this fact against the database of graduates from FoL CU). The applicant must send the authenticated copy of the master's diploma and the appendix to the diploma via regular mail no later than on 30 April 2018 to the following address:

Where a paper application is filed, the required documents are enclosed with the application and are filed along with it.

In case of applicants who will have passed their secondary school-leaving exam in the autumn session, as well as in case of applicants whose applications for the recognition of education acquired abroad will not have been decided on by 30 September 2018, the deadline for the verification of the fulfilment of admission requirements (including requirements verified on the basis of documents, such as a secondary school-leaving exam certificate), is 22 October 2018. The same deadline, by which the required education must be documented under section 48 (3) of the Higher Education Act, applies to the verification of the fulfilment of admission requirements in the case of applicants for master's programmes of study which are continuations of bachelor's programmes of study, as well as to applicants for doctoral programmes of study who will have completed their studies in bachelor's or master's programmes of study between 1st and 30th September 2018.

If the documents proving the completion of higher education (a diploma and appendix to the diploma, or, as the case may be, a certificate) have been issued by a higher education institution seated in another state than the Czech Republic, Slovak Republic, Poland, Hungary, or Slovenia, it is also necessary to submit a certificate by which the higher education, or its part, is recognised in the Czech Republic, unless an international agreement stipulates otherwise. The CV and the dissertation project must also be submitted in the Czech or Slovak language; in the case of study in English, they may be submitted in the English language.

Doctoral study programmes train highly specialised staff for science and research activities. Kinanthropology

Kinanthropology focuses on the interdisciplinary study of human movement, with respect to Physical Education, sport, recreation, rehabilitation and physiotherapy. Biomechanics

Biomechanics applications are encountered in a wide range of sciences and professional activities. Biomechanics in this form can be applied not only in basic research, but also in a wide range of professional activities such as physiotherapy, ergonomics, forensic and biomedical engineering, sport etc. The relevant departments of Charles University and the Academy of Sciences of the Czech Republic facilitate large-scale, interdisciplinary education in doctoral studies, with regard to a particular application.
