A key goal of the Charleston programme is to provide fellows with direct, hands-on experience across sectors. This will be achieved through a **mandatory secondment in the non-academic sector, lasting between 3 and 6 months, which will be integrated into their research project**. The secondment can be split into up to two parts and scheduled at any point during the project. Each part of the secondment must last a minimum of six weeks. The secondment must take place at a single non-academic host institution.

A diverse range of partnerships with **13 non-academic institutions** has been established to offer attractive hosting opportunities for these secondments. These partnerships include private companies, hospitals, public institutions, and non-governmental organizations, all committed to hosting fellows, collaborating on research projects, and providing experienced mentors from the non-academic sector.

If a suitable host institution is not found within the existing network, the postdoc can propose an alternative non-academic institution.

The CNB researchers are especially skilled in quantitative modelling, both empirical and structural, as the bank uses such models routinely for policy analysis and forecasts. The CNB researchers also often publish in leading scientific journals.

The coordination and implementation of research is carried out by the Research Division, which is part of the Research and Statistics Department. The division consists of two units – the Financial Research Unit and the Economic Research Unit. Access to broad sources of data (including individual level data and high-frequency financial data) on financial sector and the macroeconomy is possible for research purposes. Wide range of specialized software and high-performance computing are available. Broad knowledge base in economic modelling is another asset, as are the regular internal and external research seminars. The CNB maintains frequent contact with international research institutions and other central banks and supports conference travel of its researchers.

The Ministry of Industry and Trade is the central body of the government administration involved in:

- the National Industry Policy, the Energy Policy, the Trade Policy in the context of the European Common Market, the Export Promotion Policy, the Integrated Raw Materials Policy and the Use of Mineral Resources;
- Business and Investment Promotion in the areas of Manufacturing Industry and of Industrial Research and Development including the use of European funds;
- Internal trade and Consumer protection in the context of the European Consumer Policy;
- Promotion of Small and Medium—Sized Companies with the exception of regional business support and trading matters;
- Technical standardization, metrology and state quality control;

- Industrial research, engineering and technology development;

Department of Brownfields and Innovation Business Development (Odbor brownfields a rozvoj inovačního podnikání)

- Topic: Application of regional and selected sectoral state aid rules for strategic projects in industry
- Description: The Ministry of Industry and Trade implements public support for large investors and municipalities that want to be ready for the arrival of a new investor. Support is generally provided under the General Block Exemption Regulation (GBER) or the Temporary Crisis and Transformation Framework, and the Net Zero Industry Act is now in force. Individual public aid notifications under the TFEU associated with the Chip Act are also consulted. In terms of Czech national regulations, these include state aid under the Investment Incentives Act and subsidies granted under the Act on budgetary rules. The aim of the internship would be to get acquainted with the individual legal acts issued within the framework of the above-mentioned legislation, to check the appropriateness of the references used, possibly to make a comparison with the latest amendments to the above-mentioned legislation, and also to prepare the drafting of new legal acts for the new Strategic Investments for a Climate Neutral Economy programme and for new strategic projects under the new EU regulations)
